I. ARE YOU A SETTLEMENT CLASS MEMBER?

For you to be eligible for benefits, you must be a member of the Settlement Class and file a valid Claim Form. Unless you are in one of the categories excluded below, you are a Settlement Class Member if:

You purchased electricity in Pennsylvania from U.S. Gas & Electric, Inc., Energy Services Providers, Inc., and/or Pennsylvania Gas & Electric at any time up to and including February 13, 2017.

You are not a Settlement Class Member, even if you meet the above criteria, if:

- You are the judge to whom this Action is assigned, or any member of the judge's immediate family;
- You previously released claims against U.S. Gas & Electric, Inc., Energy Services Providers, Inc., and/or Pennsylvania Gas & Electric, pursuant to the settlement of the administrative proceeding that was filed in the Pennsylvania Public Utility Commission and docketed at C-2014-2427656;
- You are an entity in which U.S. Gas & Electric, Inc., Energy Services Providers, Inc., and/or Pennsylvania Gas & Electric have a controlling interest;
- You are a parent, subsidiary, or affiliate of U.S. Gas & Electric, Inc., Energy Services Providers, Inc., and/or Pennsylvania Gas & Electric;
- You are an officer, director, or employee of U.S. Gas & Electric, Inc., Energy Services Providers, Inc., and/or Pennsylvania Gas & Electric; and/or
- You are an immediate family member of an officer, director, or employee of U.S. Gas & Electric, Inc., Energy Services Providers, Inc., and/or Pennsylvania Gas & Electric.

II. GENERAL INSTRUCTIONS

Read all instructions below before filling out the Claim Form. Alternatively, you can submit a claim online at www.PAEnergySettlement.com.

1. Type or print legibly all information in blue or black ink.
2. Sign and date the Claim Form under Part 2. **Your claim will not be processed if your Claim Form has not been signed and dated.**

You will receive a rejection letter if your claim is invalid, and you will receive a deficiency letter if your claim is deficient in ways that you can correct. If your claim is valid, you will be sent a check. If you want further confirmation that your claim was received, please send it via Certified Mail, return receipt requested.
